Bundle Cases

- Everyone loves procedure bundles! This is an easy way for us to gain volume outside our current market or start a relationship with an eager employer.

Bundled cases are handled differently than typical referrals. The CPTs in each encounter need to be identified (to the extent possible) prior to service. Bundle encounters can NOT be listed with their traditional insurance. Claims should NOT be sent out to insurance. Billing, front desk and schedule staff need to be clearly aware of bundle protocols.
